Tradescantia cultivar registration

This form is to register a new cultivar of *Tradescantia*. Before you start, make sure

you're ready:		
	Is your cultivar distinct, stable, and uniform? It should be different from any cultivar that already exists, and it should maintain its characteristics when propagated. Be particularly mindful of the fact that many tradescantias vary widely in different growing conditions, and what seems to be a new sport could be within the natural variation of an existing cultivar.	
	Decide what name you want to give the cultivar. The name will be checked to make sure it follows the rules, which you can read here: ishs.org/sites/default/files/static/ScriptaHorticulturae_18.pdf. Or in simplified form here: tradescantia.uk/article/naming-rules.	
	Gather information about where you cultivar came from and how it was created. Who bred or found it? Who chose the name? Who introduced it into cultivation by selling or distributing it?	
	Take lots of quality photos of the plant, making sure to show any characteristics that distinguish it from other similar plants. In submitting photos as part of a registration application you agree, as copyright holder, to their use by the ICRA for <i>Tradescantia</i> for scientific or educational purposes in relation to the registration and correct naming of plants, in electronic and hardcopy media.	
	It's a good idea (but not required) to send a sample of the plant for documentation. Ideally this would be a fresh, live sample that can be compared to other living plants of similar cultivars in order to describe it. This will be used to make a herbarium specimen to define a nomenclatural standard for the cultivar.	
	Your cultivar will be published and formally established after you register it with the ICRA, but this might take some time. If you want to be sure your name gets priority, you may want to publish it yourself immediately after registering.	
	Be aware that your name and address will be stored permanently in the cultivar register, along with the names and addresses of anyone else involved with the cultivar. Your name, city, and country (but not full address) will also be published online and in hardcopy.
